NSE co-location probe: **CBI grills Subramanian**

THE CENTRAL BUREAU of Investigation (CBI) has collected relevant documents from the Securities and Exchange Board of India (Sebi) as part of its probe into the irregularities at the National Stock Exchange (NSE). The agency also questioned the exchange's former group operating officer Anand Subramanian in Chennai for the last three days, sources told FE on Mon-

The CBI had questioned former NSE CEO Ravi Narain on Saturday in connection with the alleged abuse of the co-location facility by an NSE stock broker. It had quizzed former CEO Chitra Ramkrishna on Thursday and Friday. It had issued lookout notices against Narain and Subramanian on Friday..

The CBI stepped into the case after tax raids on the Mumbai and Chennai residences of Ramakrishna and Subramanian commenced on Thursday morning. A senior I-T department official had told *FE* that financial transactions of Subramanian's wife, Sunitha Anand, a former NSE official, were also being investigated.

The CBI is also learnt to be investigating other unnamed NSE officials to gather evidence on allegations that some bro-

kers received preferential access through the co-location facility at the stock exchange. Early login and 'dark fibre', which allows a trader a split-second faster access to the data feed of an exchange, could potentially result in big gains for a trader.

The CBI had booked Sanjay Gupta, owner and promoter of Delhi-based OPG Securities, and others in connection with the alleged abuse of the co-location facility. It is also investigating unidentified Sebi officials.

"It was alleged that the owner and promoter of the said private company (OPG Securities) abused the server architecture of NSE in conspiracy with unknown officials of NSE. It was also alleged that unknown officials of NSE, Mumbai, had provided unfair access to the said company using the co-location facility during the period 2010-2012 that enabled it to login first to the exchange server of Stock Exchange that helped to get the data before any other broker in the market," the CBI has said in its FIR.

It emerged that in 90% of cases, Gupta was the first to log in, which prompted murmurs in the stock broker circuit and resulted in the NSE introducing a load balancer. As per the FIR, Gupta again managed through the data centre staff of NSE to get connected to the backup servers, which were with zero load and provided far better and faster access of market feed.

The agency said he manipulated Sebi's inquiry against the role of OPG Securities in the misuse of tick-by-tick architecture of servers by bribing officials of the market regulator.

The ambit of the tax raids includes "suspected generation of black money by way of abuse of co-location facility in the NSE", an official said.

Onion exporters await arrival of summer crop



EXPORTERS ARE WAITING for the arrival of summer onions in the market, since the red onion variety currently available is not considered suitable for exports because of its shorter shelf life. The summer onions are expected to hit the market in the middle of March.

As per data available with the Agricultural and Processed Food Products Export Development Authority (APEDA), onion exports dropped 24% in the April-November period of the current financial year to 10.55 lakh tonne from 13.92 lakh tonne in the same period last year.

Onion exports from Maharashtra have declined 35% from 6.72 lakh tonne between April and November FY21 to 4.34 lakh tonne during the same period in the current fiscal. The state had exported at least 8 lakh tonne in 2020-21, while the figure for 2019-20 was 7.29 lakh tonne. Maharashtra is among the largest cultivators of onions in the country.

PK Gupta, acting director, Horticultural National Research and Development Foundation, attributed the decline in exports to the higher prices in the domestic market. Onion prices in international markets ranged from ₹18.75 to ₹22.50 per kg, while prices in domestic markets were between ₹20 and ₹25 per kg.

The government has not banned onion exports, but the lack of benefit has made exporters shy away, he said.

Ajit Shah, president, Horticulture Produce Exporters Association, said onion prices should reduce once the summer crop starts arriving in the markets. At present, the red onion variety is selling for ₹2,500 per quintal in the Lasalgaon wholesale market. "Onion from Pakistan is being preferred by other markets since it is available for \$350 a tonne, while Indian onion is \$550 per tonne. The season in

Pakistan is about to end, while the Indian summer onion crop season begins soon and can continue for three to four months. This is when exports are likely to pick up," he said. Freight charges almost

doubled from ₹5 per kg to ₹11-12 per kg this financial year, which also affected onion exports. The availability of containers was also an issue, Shah said. Besides, the quality of onions was also poor as most of the produce was affected by unseasonal rain in Maharashtra, he said.

Suvarna Jagtap, chairperson of the Lasalgaon Agriculture Produce Market Committee (APMC), said onion arrivals have reduced to around 20,000 quintal a day from nearly 40,000-50,000 quintal at the APMC and its sub-yards. This time, MP and Gujarat have also reported a good crop and therefore prices should remain stable, she said.

TRIL Urban Transport is a subsidiary of Tata Realty and Infrastructure, is the developer of this project. Tata will have 74% stake in the SPV while 26% will be with Siemens Project Ventures GMBH, a subsidiary of Siemens Financial Services. Siemens Financial is

the financial arm of Siemens. Siemens'scope of work includes project management, turnkey electrification, signalling, communications and depot works.

The Tata-Siemens consortium has signed concession agreement for ₹8,313 crore Pune Metro Line three with PMRDA. This is the first PPP project under the 2017 Metro Rail Policy in the country. The initial concession period is of 35 years. The project has received Viability Gap Funding of ₹2,351 crore. Line-3 is estimated to have 30,000 Peak Hour Peak Direction Traffic or people per hour per direction.

The court, in its order, observed that there is no merit in the petitioners' contention that BMC Commissioner was not competent to issue notification.

The bench accepted submission by advocate Sachindra Shetye for the SEC, who said the contention of the petitioners was misplaced as the poll body on January 27, 2005 had stipulated that while the state government cannot change the overall boundaries of the civic body, it put no restrictions on changing the boundaries of individual wards.

The BMC had issued a notice to the bungalow under section 488 of Mumbai Municipal Corporation (MMC) Act, 1888 regarding the inspection. According to sources, after the Bombay High Court questioned the BMC over its promptness in demolishing actor Kangana Ranaut's bungalow, the civic body is proceeding with caution in Rane's matter.

The BMC's action came af-

ter Right To Information (RTI) activist Santosh Daundkar filed a reminder complaint alleging it did not take any action on his previous complaints regarding illegal construction of the bungalow.

The bungalow has been in

the news for the past few years over alleged illegalities. Daundkar said he had filed a complaint since the bungalow, built within 50 metres of the sea, violated CRZ rules, 1991.

Mumbai Mayor Kishori Pednekar said the civic body's action was as per the law. "The BMC is not doing this suddenly.

but Mr Rane himself has said the BMC had gone to them four years ago also. Hence, the BMC is just doing its job of inspection and we are certain that Mi Rane will cooperate," she told the reporters.

On Monday, BJP MLA and Rane's son Nitesh Rane told the reporters about the notice.

"We will cooperate with the BMC and my father (Narayan Rane) is present at the bungalow," he said.

Earlier, on Saturday, ad dressing a press conference Rane denied any illegality in the bungalow.

Prithviraj Chauhan, Assistant Municipal Commissioner of BMC's K west ward who conducted the inspection, did not respond to calls.

The notice to Rane comes in the backdrop of the father-son duo taking on the Shiv Sena and criticising the party leadership. Recently, at a press conference, Rane had alleged that Uddhav Thackeray's bungalow in Bandra was constructed illegally and it was regularised by paying a penalty to the BMC.

Anganwadi workers to begin 3-day protest tomorrow over wages, pension

ANGANWADI WORKERS in Maharashtra will be undertaking a three day sit-in protest at Azad Maidan ground from February 23 seeking an increase in their honorarium to up to Rs 15,000 per month along with a monthly pension after retirement. The present honorarium for anganwadi workers and helpers is Rs 8,500 and Rs 4,500 respectively.

Even as anganwadi workers in Delhi have been on strike since January 31, a total of 200 healthcare staffers from the districts of Thane, Palghar, Mumbai and Raigad will be protesting till February 25. Subsequently, between February 28-March 7, they will hold district-wise agitation in front of the offices of Zilla Parishad and Child development project officers. They have also scheduled a morcha on March 9, close to the state budget on March 11.

"After serving for 25 years, the amount of Rs 1 lakh is too less. Aganwadi workers end up spending it, ending up penniless," said Kamal Parulekar, secretary, Anganwadi Sevika Union general.

BMC to appoint steering panel to oversee Shivaji Park maintenance

FOLLOWING THE controversy over the dust-mitigation work in Shivaji Park in Dadar, the Brihanmumbai Municipal Corporation (BMC) has decided to appoint a citizen-led steering committee to oversee the maintenance of the park.

BMC will float a Rs 60 lakh tender for the maintenance of the park that will include security, watering of the lawn and trees around the periphery, maintenance of newly installed sprinklers and rainwater harvesting units. Gravel has been laid under the track. The same method has been used at Wankhede Maidan and Brabourne Maidan in Mumbai," stated the BMC. Mumbai Mayor Kishori Pednekar inspected the ongoing work at Shivaji Park on Monday.


