Tata Steel's Q2 FY17 Key Production and Sales Figures

Jamshedpur, October 6, 2016:

Tata Steel Limited registered Hot Metal production of 3.12 million tonnes in Q2 FY'17 (up by 17 per cent y-o-y) and 6.14 million tonnes in H1 FY'17 (up by 17 per cent y-o-y). Crude steel production was 2.82 million tonnes in Q2 FY'17 (up by 13 per cent y-o-y) and 5.35 million tonnes in H1 FY'17 (up by 10 per cent y-o-y). Saleable Steel production increased by 11 per cent y-o-y in Q2 FY'17 (to 2.71 million tonnes) and by 9 per cent y-o-y in H1 FY'17 (to 5.06 million tonnes).
