Opposition parties want survey for oil refinery at Barsu stopped

Fadnavis says govt ready to talk but will not tolerate opposition just for politics

THE OPPOSITION parties in Maharashtra have asked the state government to stop the soil survey process for the proposed oil refinery at Barsu-Solgaon in Ratnagiri district and alleged that the government was misusing the police machinery to threaten villagers and activists opposing the project.

Speaking to media during his Assembly election campaign in Karnataka on Tuesday, Deputy Chief Minister Devendra Fadnavis said that the government was ready to hold talks with peaceful protesters but will not tolerate opposing the project just for the sake of politics. He added that the present state government was just taking the work forward and to hold the Thackeray-led Maha Vikas Aghadi (MVA) government that finalised the project.

First they opposed Metro card at Arey. Then they opposed the port. The Sanjay Gandhi Mahamarg and now they are against the refinery... We respect the Opposition's stand. And if there are some misunderstandings or apprehensions, we are willing to address it, but if they are opposing for political gains, we will not tolerate it," said Fadnavis.

Former environment minister Aaditya Thackeray said that the MVA had put the condition to take locals into confidence before moving ahead with the project.

The Ratnagiri Refinery & Petrochemicals Ltd. (RRPCL), promoted by the three major public sector oil companies —

Indian Oil Corporation Ltd, Bharat Petroleum Corporation Ltd and Hindustan Petroleum Corporation Ltd — was originally planned in Nanar village of Ratnagiri district. Shiv Sena opposed the project citing local opposition and after party president Uddhav Thackeray became the chief minister, he announced that the project will not take off from Nanar. Since then, the location was finalised at Barsu-Solgaon area, where local residents opposed the project citing possible environmental damage.

Earlier in the day, Leader of Opposition Ajit Pawar said: "It is dictatorial of the government to arrest protesters and stop the media from telecasting the proceedings at Barsu-Solgaon. The government must respect the sentiments of the people and stop the survey process immediately."

On Tuesday morning, Nationalist Congress Party (NCP) chief Sharad Pawar held talks with Industries Minister Uday Samant and asked him to release individuals arrested for protesting against the project. Two top leaders of the

protest movement, Satyajit Chavan and Mahesh Chavhan, were arrested by the Ratnagiri police Sunday and sent to judicial custody. A total of 110 local residents were arrested for attempting to stop the survey.

Congress legislative party leader Balasaheb Thorat tweeted, "At the refinery site in Barsu, Ratnagiri, local citizens, women and children are protesting against the refinery survey... The unwarranted police action against the protesters and the media representatives is highly condemnable. The government should stop this oppression and the survey immediately."

He further said, "Fourteen citizens have died in the Maharashtra Bhushan award ceremony due to the government want to kill the farmers by taking police action against them for protesting at Barsu? Stop this oppression immediately!"

The Shiv Sena (UBT) also slammed the state government. "I am afraid that on the lines of the Jallianwala massacre in

Punjab, there will be a massacre in Barsu-Solgaon where thousands of villagers are opposing the proposed petrochemical refinery project. The state is misusing police machinery to suppress the protest and threaten the villagers. They might shoot down the villagers," Shiv Sena (UBT) leader and Rajya Sabha MP Sanjay Raut said.

Alaying apprehensions that it would damage the environment, Fadnavis said that the green refinery planned in Barsu-Solgaon adequate environmental safeguards.

"The government's repression in Barsu is unfortunate. The government will not hesitate to attack the son of the soil of Konkarn who are protecting the nature. Our stand is clear (on the refinery). First stop the activities of the villagers. Interact with them. Tell them who are going to benefit... As the MVA had put the condition, the villagers should be taken into consideration before setting up the refinery... There should be transparency in the whole process and the final decision must be of the local villagers," said Shiv Sena UBT leader Aaditya Thackeray.

"The concerned Regulatory Authority shall split and transfer the prior-Environmental Clearance, on recommendation of the concerned Expert Appraisal Committee to the other legal persons for the respective projects," it adds.

Hailing it as a step towards ease of doing business, Kishor Bhatija, vice-president NAREDO Maharashtra, and Managing Director — K Raheja corp, said, "Earlier a particular developer was unable to carry the distressed project, the entire MoU was expected to be transferred to another developer for which the new developer need not obtain the EC... now, with the revised notification, the stressed project can be transferred in parts... like if a project is larger in size and two developers can execute the project, which was not allowed otherwise. It also makes it possible to bring funding..."

Govt allows splitting of environmental clearance for projects

DEVELOPERS WILL henceforth not be required to take a duplicate environmental clearance (EC) for a project and can split in case of a change of developer, according to a gazette notification issued by the government of India on April 21.

The revised provision reads, "A prior-Environmental Clearance granted for a specific project, except mining projects, may be split among two or more legal persons, entitled to undertake the project and transferred during the validity to another legal person on application made by the transferee in the format specified on PARIVESH portal to the concerned Regulatory Authority along with requisite documents."

"The move will speed up projects that are stuck over obtaining duplicate EC approvals from the authority concerned, he added.

CM, Deputy CM travel out of Mumbai, no cabinet meet this week

AMID SPECULATIONS of political instability and heightened activity in Maharashtra, Chief Minister Eknath Shinde has gone on a holiday to his native village Dare in Satara district for three days.

With Deputy Chief Minister Devendra Fadnavis busy campaigning in Karnataka elections, and later scheduled to travel to Mumbai on an official visit, the state cabinet meeting will not be held this week. With Shinde and Fadnavis both missing from the state capital, ministers in the state cabinet to have chosen to remain in their respective districts.

Shinde left for Dare on Monday and will return to Mumbai on Wednesday night. The Opposition slammed Shinde for holidaying at a time when public attention was being taken against Barsu-Solgaon area in Ratnagiri district for opposing the upcoming oil refinery project.

Fadnavis will be campaigning in Karnataka for next two days and then will go to Nagpur. He will later visit Mauritius where he is to unveil a statue of Chhatrapati Shivaji Maharaj. Due to his pre-planned programme, the send-off ceremony of outgoing state Chief Secretary Manu Kumar Shrivastava was also held a day ago in the presence of Shinde and Fadnavis.

# FORECAST FOR FY24 Adani Ports capex to be ₹6k cr: S&P

Mumbai, April 25

**ADANI PORTS AND** Special Economic Zone (APSEZ), an Adani group firm, will incur capex of ₹6,000 crore (about \$732 million) in FY24, while it will have adequate liquidity during the fiscal, according to S&P Global Ratings.

"Adani Ports should have adequate liquidity over the next 12 months ending March 31, 2024. In our view, the company will remain flexible with capex, adjusting it according to business performance and funding availability," S&P said in a statement.

"We expect Adani Ports to have a sufficient cash balance to repay \$130 million of the notes. The company will capitalise on its healthy operating cash flow, which we project at ₹8,900 crore (\$842 million) for fiscal 2024," it added.

APSEZ's bond tender should reduce its debt well ahead of its \$650 million 3.375% senior unsecured notes maturing in July 2024. The Indian ports and logistics operator announced a tender offer for bonds worth \$130 million, which the company will use to partly pre-pay near-term debt maturities.

"The transaction, if accepted by investors, will facilitate APSEZ' strategy to reduce refinancing risks. We believe it is an opportunistic exchange, reflecting the com-

pany's proactive management of upcoming debt maturities in advance," it said.

APSEZ handled about 339 million metric tonne (MMT) of cargo volume in FY23.

"Although this was slightly below our estimate of about 355 MMT, we expect the company to maintain robust EBITDA margins of 55-60% over the next two fiscals, underpinned by a stable operating performance," it added.

**TATA CONSUMER PRODUCTS** on Tuesday said its consolidated net profit for the March quarter increased 23.5% year-on-year (y-o-y) to ₹269 crore. This was in line with Street estimates, which had pegged March quarter net profit at ₹268 crore, according to a poll of analysts by Bloomberg.

The Tata group company said its consolidated revenue for the quarter rose nearly 14% versus last year to ₹3,619 crore, ahead of Street estimates.

**TECHNOLOGY COMPANY PERSISTENT** Systems on Tuesday, reported a 3.92% quarter-on-quarter (q-o-q) growth in revenue to ₹2,254.47 crore in the January to March quarter.

Persistent's net profit was up 5.7% qoq to ₹251.51 crore, however EBIT margins remained flat at 15.4%. Annual revenue for the first time crossed the billion-dollar mark in FY23. Persistent's services business, which accounts for 93% of revenues, was up 5.5% while IP-led business declined by 14.6% during the quarter.

Sunil Sapre, executive director and chief financial officer, Persistent Systems, said they were able to maintain margins due to multiple deals.

# Double-digit growth for PepsiCo in India

**GLOBAL FOOD AND** beverage maker, PepsiCo, on Tuesday said its Indian unit delivered double-digit organic revenue growth in the March quarter (Q1) of 2023. While beverage unit volumes witnessed strong growth, snacks volumes witnessed a decline in the country during the quarter. Even then, India has been among PepsiCo's strong markets in the Africa Middle East South Africa (AMESA) region, driving growth along with Egypt, Saudi Arabia and Pakistan, the company said.

Globally, PepsiCo's average prices increased 16%, but organic volume decreased 2% globally amid a volatile operating environment.

Emerging markets including India appeared to have bucked this trend, as sales momentum remained strong. Overall, PepsiCo's net revenue

for the March quarter came in at \$17.85 billion, up 10.2% versus the previous year, led largely by price-led growth. In prepared remarks on Tuesday, PepsiCo's management said each of its international divisions had reported strong organic revenue growth in Q1. In particular, the AMESA region led growth. Though outside of AMESA, PepsiCo said, many of its other

developing and emerging markets also delivered strong results, including Mexico, Brazil and Vietnam. "We are pleased with the performance of our international business, which delivered nearly 40% of our total net revenue in 2022 or approximately \$34 billion. We remain encouraged by the long runway for growth in many markets and categories," the

The company board on Tuesday recommended a final dividend of ₹8.45 per equity for FY23. The dividend, if approved by the members at the annual general meeting, will be paid within 30 days of its declaration, the company said.

Tata Consumers said its India beverages business grew 8% for the quarter, with tea volumes returning to growth, up 3% y-o-y.

Its international business, Tata Consumer said, recorded 11% revenue growth (1% ex-acquisitions) in constant currency terms, with Ebitda in line with last year.

Managing director & CEO Sunil D'Souza said the company saw early signs of green shoots in its branded tea business, with the interventions put

in place starting to yield positive results. "In our other core business of salt, we continued to execute strongly and have gained market share despite pricing actions taken to mitigate inflation. Our innovation across categories has picked up pace significantly with the number of new product launches in FY23 being almost two times of FY22," he said.

Tata Starbucks recorded strong revenue growth of 48% for the quarter, bringing FY23 growth to 71%, albeit on a base that was impacted by the pandemic, the company said.

Tata Starbucks opened 71 new stores during the year and entered 15 new cities — the highest ever annual store addition — taking the total number of stores to 333 across 41 cities.

# Serum arm to pump in another \$150 mn in Biocon

**SERUM INSTITUTE OF** Life Sciences will invest an additional \$150 million in Biocon Biologics as the two partners have decided to restructure the deal signed in 2021, Biocon said.

With the fresh capital infusion, Serum's total investment in Biocon Biologics will touch \$300 million. Serum Life Sciences, a part of vaccine major SII, will make an additional equity investment of \$150 million through the conversion of the \$150 million loan provided to Biocon Pharma, a wholly owned subsidiary of Biocon, into equity in Biocon Biologics.

Biocon Biologics will have access to 100 million doses of vaccines annually together with the distribution rights to Serum's vaccine portfolio, which will add to Biocon Biologics' product portfolio for global markets. In 2021, Biocon Biologics had said it will offer around 15% stake to Serum Institute Life Sciences at a post-money valuation of about \$4.9 billion. Biocon Biologics was to get an access to 100 million doses of vaccines per annum for 15 years, primarily from Serum Life Sciences' upcoming facility in Pune.
