All the biomedical wastes are disposed-off as per applicable rules. The hospital has autoclave, plastic shredder, bins of various colors, effluent pit etc. for treatment and handling of bio-medical waste. Disposal of incinerator waste is done through Common Bio-medical Waste treatment facility.

PART - G

Impact of the pollution abatement measures taken on conservation of natural resources and on the cost of production.

- ETP has been installed to treat the effluent generated in hospital premises. After effluent being treated and tested, the treated water is used for parks and garden development. This eliminated the cost of water supply via tanker.
- Bins and plastic bags are used as per BMW rules 2016 to handle all type of waste as per specified color coding.
- Disposal of incinerator waste is done through Common Bio-medical Waste treatment facility. Estimated annual cost is around 230 Lakh for disposal of incinerator waste for FY23.

Jharia Division of Tata Steel Ltd. is committed to improve safety and environment by strictly practicing Environmental Management System of company. Various programs are arranged such as World Environmental day, Annual Flower Show, Green school project, Tata volunteering week, etc. for public awareness. Also, various initiatives for biodiversity enhancement in the region have been taken such as Bird Niche Nesting, Development of Butterfly garden, Medicinal Garden, Nursery

1. Shredder at hospital was commissioned in March'2015.

2. We are providing safe drinking water from our water treatment plant & MADA to our employees.

3. We are regularly sprinkling water in an around the units to suppress dust.

4. The waste generated from hospital and ancillary dispensaries are stored, treated and disposedoff centrally as per the BMW rules, 2016.

5. The staff of hospital are trained regularly for handling of bio-medical waste.

6. Regular monitoring of Ambient air quality, hospital effluent and stack emission by our separate Environment Cell as well as MoEF/NABL accredited laboratory on regular basis.

7. We do annual tree plantation job in company lease hold areas every year to improve the greenery of region.

8. Regular thrust on Environment awareness conducting training classes at P.T.I., Jamadoba.

9. We are an IMS certified unit (ISO 9001:2015, 14001:2015 and 45001:2018 certified) along with SA: 8000 (Social Accountability).
