Pursuant to Section 108 of the Companies Act, 2013, Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time and Regulațion 44 of the Securifies and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the Secretarial Standard on General Meetings (SS2) issued by The Institute of Company Secretaries of India, the Company is pleased to provide remote e-voting facility to all its Members to cast their votes on all resolutions set forth in the Notice of the AGM using electronic voting system from a place other than the venue of the AGM ('remote e-voting'), provided by NSDL and the business may be transacted through such voting. The voting rights will be on the basis of shareholding as on the cut-off date of Tuesday, August 1, 2017. Any person who is a Member of the Company as on the cut-off date is eligible to cast vote on all the resolutions set forth in the Notice of AGM, using remote e-voting or voting at the AGM.

The remote e-voting period commences on Thursday, August 3, 2017 (9:00 a.m. IST) and ends on Monday, August 7, 2017 (5:00 p.m. IST). During this period, Members may cast their vote electronically. The remote e-voting module will be disabled by NSDL thereafter. Once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently. The facility for voting through electronic voting system or ballot paper shall also be made available at the AGM venue and Members who have not already cast their vote by remote e-voting shall be able to exercise their right to vote at the AGM. The Members who have cast their votes by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.

A person who has acquired shares and become a Member of the Company after the dispatch of notice of AGM and holding shares as of cut-off date at Tuesday, August 1, 2017, may obtain the login ID and password by sending a request at evoting@nsdl.co.in.
